STERILIANT FOR STERRAD® NX:

• Sterilant (H2O2) hydrogen peroxide cassette compatible with STERRAD NX with Leak Indicator on the sterilant/cassette. Each box should come with 5 cassettes and each cassette should be capable of performing 5 sterilization cycles.

PACKAGING ROLLS:
