# **Technical Specification**

- System should have conduit access for aerosol through the HME by turn of a Knob.
- Double Limb circuit should allow placement of aerosol. delivery through any jet nebuliser/ Vibrating Mesh/MDI either Distal or Proximal side in the Inspiratory limb so that drug delivery can be optimized.
- System should allow Breath Actuated Nebulisation.
- Wye Piece with sensor input ports

- Should have Integrated Sealed valve system with universal Adaptor for Jet Nebuliser in Inspiratory Limb
- Should be compatible with any jet or vibrating mesh nebuliser or with MDI.
- Should have ISO 13485 or CE Certified.
- Spare Conduit Access for Aerosol HME should be available as an option with a usage life of 24 Hrs.
