ANNEXURE-I

Specification for Dual Chamber Temporary Pacemaker:

- 1. Should have an additional internal battery back up to facilitate quick change of normal AA battery.
- 2. Should be able to be attached easily to patient arm, let or IV pole.
- 3. Should have rapid atrial pacing to manage atrial flutter safe reliable.
- 4. Should have safety awareness ranges to alert clinician to area of caution.
- 5. Should have modes AOO, AAI,AAT,VOO,VVI,VVT,DDD,DDI,DVI,DAI,DOO, DDT, VDD, AND VAT.
- 6. Should have basic pacing rate to 30 to 180ppm which is continuously adjustable.
- 7. Should have rapid atrial pacing rate 40 to 1000ppm.
- 8. Should have rapid atrial pacing rate:
 - 40 to 120ppm in steps of 2ppm increments,
 - 120 to 200ppm in steps of 5ppm increments,
 - 200 to 400ppm in steps of 10ppm increments
 - 400 to 1000ppm in steps of 50 increments.
- 9. Should have an output amplitude 0.1 to 20mv.
- 10. Should have Atrium pulse width 0.7ms Ventricle 0.5ms and high rate 1.0ms.
- 11. Should have sensitivity 0.1 to 20mv which is incrementally adjustable.
- 12. Should have refractory 400ms for AXX modes and 250ms for VXX modes.
- 13. Should have blanking pace 125ms and sense 75ms.
- 14. Should have work on 2,1.5 AA batteries which are very easily available in the market.
- 15. Should have runaway protection depending on rate settings.
- 16. Should have back up battery life > 150hrs.
- 17. Should have AV/PV delay 1.5ms to 300ms. Setting automatic depending on rate manual.
- 18. Should have PVARP 100 TO 500ms setting automatic depending on rate or normal.
- 19. Should have TARP AV Delay +PVARP with minimum rate + 60ppm.
- 20. Should have AV/VA blanking 70ms.
- 21. Should have UTR/MTR rate + 40ppm.
