Technical Specification

- 1- The scope should be having a viewing angle of 5^O.
- 2- The scope should have caliber of 6/7.5 Fr or more.
- **3-** The caliber of distal tip of sheath should be 6 Fr.
- **4-** Working length should be 430 mm or more.
- 5- Total length of the instrument should be 600mm or more.
- **6-** Should have incorporated Marberger type lateral offset eyepiece.
- 7- Should have incorporated fiber optics for light transmission.
- 8- Should have two lateral Irrigation ports with leur type connectors.
- 9- Should have main instrument channel of caliber at least 4.2 x 4.6 Fr.
- 10- Should have auxiliary instrument channel for use of 1x4 Fr or 2x2.4 Fr accessory instrument.
- 11- Should have automatic valve facility for inserting instruments.
- 12- The complete set should be fully autoclaveble.
- 13- Should be provided with the following accessories.
- 14- The quoted scope should be fully compatible and functional with the existing camera processor and light source/light cable (Richard wolf make) of the Department of General Surgery.
- 15- The instrument should have BIS/Euro. CE/USFDA approved certification.
- **16-** Manufacture/supplier should have ISO certification.
- 17- Electrical safety standards such as IEC 60601-1 or equivalent BIS standard should be confirmed.
- **18-** Should meet internationally recognized standard for electromagnetic compatibility (EMC) for electro medical equipment's such as 60601-1-2, IEC 60601-1-2 or equivalent BIS standards.
