<u>Specifications for 12 Channel ECG Machine with 7 Inch Colour TFT- LCD display, full</u> <u>qwerty keypad, recording paper 210mm width battery backup:</u>

ECG Machine is primary equipment to record ECG Signal in various configurations. 12 Channel with interpretation is required for recording and analyzing the waveforms with special software.

1. Operational Requirements

- a. The ECG Machine should be able to acquire all 12 Leads simultaneously and interpret them.
- b. Should be easily portable & should be provided with Handle.

2. Technical Specification

- a. Should acquire simultaneous 12 lead ECG for both adult and pediatric patients.
- b. Should be upgradeable to 18 lead ECG.
- c. Should have Real time Color LCD display of ECG waveforms
- d. **Sensitivity:** 10 mm/mV ±2%,
- e. Common mode rejection ratio: >=100 dB,
- f. Frequency response: 0.05 Hz to 150 Hz,
- g. Electrode check: Every electrode except N(RF),
- h. Waveform status detection: Electrode detachment

 - 2. Should have an inbuilt storage memory of at least 400 ECGs with easy transfer by optional data card.
 - 3. Should display all 12 lead waveforms on the screen for quality assessment checks prior to print.
 - 4. Should have interpretation facility of the amplitudes, durations and morphologies of ECG waveforms and associated rhythm for adult and pediatric patients. (Approx, 200 Clinical Findings and 5 Judgemental categories)
