Technical Specifications for Ultrasonic Cleaner

- 1. Must offer Silent performance
- 2. Unit should have a wear- resistant stainless steel ultrasonic tank
- 3. Unit should have a leak proof control unit integrated in a durable stainless steel casing.
- 4. The useable tank capacity should be minimum 1.7 liters and max capacity of at least 2.7 liters.
- 5. The unit should offer good cleaning results using the optimal ultrasonic technology
- 6. The unit should have a Degas function for Quick and optimal cleaning capability
- 7. The unit should be capable of exerting a uniform cleaning intensity even on large items.

- 8. Machine should have solution warm up feature with 5 degree increments with heat rang of 30-80 degrees centigrade
- 9. Unit should be supplied with
 - i. Plastic lid for quicker heating and to prevent any dust infilitration
 - ii. Stainless steel basket for storage of cleaning items
 - iii. Stainless steel immersion basket for cleaning small and delicate items
 - iv. Acid bath insert for acids and fluids not suitable for use in the stainless steel tank
 - v. Stainless steel cover for use with the cleaning jar
 - vi. Cleaning jar for the use of additional cleaning fluids
