Technical Specification for Incubator:

- Inner Chamber should be made up of Stainless Steel and Outer abrasion resistance and durable finish by heat cured epoxy coating on steel exterior.
- Should have capacity around 400 Litters or better.
- Temperature range should be ambient+5°C to 70°C.
- Control Accuracy should be ± 0.2 °C or better.
- Uniformity should be $\pm 1^{\circ}$ C or better
- Should have eye level door mounted Controller for easy access and mounting.
- Should have long life glass sheathed heaters.
- Should have excellent control accuracy with the PID temperature Controller.
- Should have timer up-to 9999 mins.
- Should have over temperature Safety.
- Should have electric overload safety with MCB.
- Should have crevice free frameless tempered glass door.
- Should have rounded corners in stainless steel chamber.
- Should have high level of uniformity due to the gentle internal circulation.
- Should have rust proof and efficient stainless steel wire mesh shelves.
- Should have silicon gasket in door.

- Shelves height should be adjustable in steps of 25 mm.
- 5 KVA stabilizer with high and low voltage protection should be provided.
- Oven should be CE certified or BIS approved
- The calibration, IQ, OQ and PQ of the instrument should be performed at the time of installation and certificates should be provided.
- Support for induction and follow up training of technical staff, on-site standardization and troubleshooting of procedures/ tests to be provided by the company.
- Three (03) years warranty should be provided
