SPECIFICATION

- 1. Accuracy- the industry as of the moment is allowed up to a plus minus 20% error.
- 2. Sample size-should not be more than 5 micro liters.\
- 3. Test time- should not be more than 10 seconds.
- 4. Interference- interference with commonly used durg and other agents along with effect on blood glucose measurement should be declared by manufacture.
- 5. Shelf life- shelf life of strip should be more than one year
- 6. Shelf life of strip after opening test strip should be individually packed or should be usable up to six month after first opening of strip box.
- 7. Coding- glucometer should be free from coding or calibration equipments in order to minimize errors at user level.
- 8. Pack size of strip should be available in minimum pack size of 50 strips.

- Trigger mechanism- glucometer should start testing only when the required sample size has been absorbed by the strip in order to minimized wastage of strips.
- 10. Operating tempretuter should be 10-40 degree centigrade.
- 11. Measurement range- most meters read in a range between 0.6mmol/l and 33.3mmol/l (10mg/dl and 600mg/dl).
- 12. Battery- battery should be able to 1000 tests approximately and preferable should be AAA battery which is economical if not AAA then battery should be easily available and adorable.
- 13. Approvals- glucometer should be USFDA approval/ CE marked/ should have equivalent regulatory approval

Note; - the selected firm will have to provide glucometer (10% of quantity) free of charges for requirement of main hospital & centres etc. MAKE: - Wockhaedt
