Sealed quotations are invited from intending registered Stockiest/ Distributors having GST and relevant documents for above said. The quotation should be submitted to Medical College Building, 2nd Floor, gate no.-5, AIIMS, Raipur office of the Stores Officer up to **26/02/2020** before **3:00 pm**. The quotations will be opened on the same day at **3.30 pm**.

Terms & Condition:

1. Quotation should be in **two- bid system** i.e. **Technical Bid** (as per **Annexure-I**) and **Financial Bid** (as per **Annexure-II**).
2. The technical bid and the financial bid should be sealed by the bidder in separate covers which will be super-scribed “**Technical Bid for Laparoscopy Vascular Instruments**” and “**Financial Bid for Laparoscopy Vascular Instruments**”. Both Sealed Envelopes should be kept in a main/ bigger envelope super-scribed as “**Quotation for supply of Laparoscopy Vascular Instruments**”.
3. **All the required documents should be enclosed in the envelope of technical bid and financial bid should be enclosed in the envelope of financial bid.**
4. Rate should be mentioned in words & figure both.
5. Taxes/GST, if any (Kindly mention in table)
6. Delivery schedule: within 15 days from the date of issue of P.O.
7. No additional documents related to this NIQ will be entertained after opening of NIQ.
8. Price should be FOR Destination basis (i.e. Department of Urology, AIIMS Raipur).
9. LD @ 0.5% of delayed supply per week or part thereof for delay of supply of material subject to maximum up to 10% should be deducted. After expiry of delivery period material cannot be accepted without extension of delivery period.
10. Quotation No/Name and due date of opening must be written on top of envelop.
11. **Brand, Make & Warranty should be clearly mentioned in offer as well as tender/ quotation. Specific authorization may be submitted with the offer/bid.**
12. GST rates applicable on your quoted item may please be confirmed. **HSN code for each item should be clearly mentioned.**
13. Any change (Upward/Reduction) in the Basic Price structure post submission of bid shall be promptly intimated to AIIMS Raipur. You shall pass the Input Credit as per the following **Anti Profiteering Clause of GST**.

B. General Requirements:

1. All quoted instruments must be from a single manufacturer.
2. All equipment supplied must be the latest models of the quoted versions.
3. Along the Bid all the firms are required to submit copy of manufacturer catalogue with clear marking of each quoted item and catalogue No. with a highlighter to avoid discrepancy.
4. All laparoscopy Hand instruments must be compatible for autoclave, ETO & Plasma sterilization.
5. Warranty: One year against manufacturing defects, rust & corruptions.
6. All instruments should be made of corrosion free surgical grade stainless steel [SS alloy grade for surgical instruments as specified in ISO 7153-1: latest ed. or EN 10088 grade or AISI grade 300-450 or equivalent standards].
7. 10% of tolerance is acceptable in sizes of the instruments mentioned above.
8. Manufacturer/ Supplier must have ISO certificate to quality standard.
9. All instruments should be BIS or European CE with 4-digit notified body no. and US FDA approved.
10. All the firms should have supplied the quoted instruments to other Central Institutes/ Govt. Institutes or reputed Private institutions and should submit a certificate of satisfactory working from the concerned Hospital/ Institution.
