## **Annexure-I**

### **Central line 3 fr (Triple lumen catheter set for catheterization of the central vein)**

1. Valve needle seldinger needle
2. Kink proof , wire with flexible complete full J-tip, Luer lock syringe (5ml) with scalper & smooth and non-rigid dilator
3. Catheter tip conical & soft.
4. Needle with back flow valve.
4. Made of thermosensitive polyurethane wit Outer diameter 5.0Fr.
5. Soft catheter tip.
6. X-ray detectable, opaque.
7. Three lumens: distal =20G; middle = 22G; proximal = 22G with separate cap for each lumen at the end.
8. Length markings for accurate catheter placement.
9. Colour-coded lock fittings.
10. Fixation wing at the channel junction for securing of the catheter should be inbuilt with catheter.
11. Protruding, adjustable fixation at the puncture.
12. 2 year shelf-life.
13. Demonstration before supply is required.
