Terms & Condition:

- 1. Rate should be mentioned in word and figures both.
- 2. Taxes/GST, if any (Should be clearly mentioned).
- 3. The AMC period will be for 12 months which commence from . .2020 and will expire on . .2021
- 4. The cost of Annual Maintenance Contract (AMC) which includes preventive maintenance and labor service.
- 5. During AMC period, the supplier shall visit consignee's site for preventive maintenance including testing and calibration as per the manufacturer's service/technical/operational manual.
- 6. The supplier shall visit four preventive maintenance calls and unlimited breakdown calls.
- 7. The supplier shall keep sufficient stock of spares required during Annual Maintenance Contract period. In case the spares are required to be imported, it

- would be the responsibility of the supplier to import and get them custom cleared and pay all necessary duties.
- 8. Payment terms: The payment of AMC will be made against the bills raised to the consignee by the supplier on six monthly basis @ 50% of annual AMC charges after satisfactory completion of said period, duly certified by the HOD concerned. The payment will be made in Indian Rupees.
