**Term & Condition:**

1. The Comprehensive Maintenance Contract (CMC) will be for five years (5 years) from the date of Work Order cum Contract.
2. The cost of CMC which includes preventive maintenance spares parts and labour.
3. There will be 98% uptime warranty during CMC period on 24 (hrs) X 7 (days) X 365 (days) basis, with penalty, to extend CMC period by double the downtime period.
4. Break down maintenance visit: As & when required (Response Time: Within 24 Hours)
5. During CMC period, the supplier shall visit at each consignee's site for preventive maintenance including testing and calibration as per the manufacturer's service/ technical/ operational manual. The supplier shall visit each consignee site as recommended in the manufacturer's manual, but at least once in 6 months commencing from the date of the successful completion of warranty period for preventive maintenance of the goods.
6. Preventive maintenance visit: For Maintenance visits at regular interval for usual maintenance & supervision failing which 25% of the contract amount per visit would be deducted as penalty.
7. Scope of work: cleaning, maintenance trouble shooting & repair of the equipment & accessories and other as per requirements.
8. The defect in the electrical installation independent of the System wiring, fluctuation of Power supply, lack of electrical earthing etc. shall be attended and rectified by the service provider.
9. All software updates should be provided free of cost during CMC (if applicable).
10. The supplier shall keep sufficient stock of spares required during Comprehensive Maintenance Contract period. In case the spares are required to be imported, it would be the responsibility of the supplier to import and get them custom cleared and pay all necessary duties.
11. The product/spares supplied during CMC period should be superior quality and high standard.
12. Service provider will provide to keep the equipment /machine in good condition.
13. Price should be FOR– Destination basis. Rate should be mentioned in word & figure both.
14. Validity of offer should not less than 90 days.
15. GST rates applicable on your quoted item may please be confirmed. **HSN code for each item should be clearly mentioned.** Taxes/GST, if any (Kindly mention in above table)
16. Please confirm if there any change (Upward/Reduction) in the Basic Price structure. And you are also required to pass the Input Credit as per the following Anti Profiteering Clause of GST.  
“Upon Implementation of GST, any reduction in the rate of tax on supply of goods or service or the benefit of input tax credit shall be passed on to AIIMS Raipur by way of commensurate reduction in the prices”
17. The GST registration details may please be furnished.
18. No any additional documents related to this NIQ will be entertained after opening of NIQ.
19. Quotation No./Name and due date of opening must be written on top of envelop.
20. RTGS details required for payment purpose also attached with invoice/bill.
21. **Payment terms:** The payment of CMC will be made against the bills raised to the consignee by the supplier on yearly basis @ 100% of annual CMC charges after satisfactory completion of said period, duly certified by the HOD concerned and supplier will submit invoice in triplicate. The payment will be made in Indian Rupees.
22. The successful bidder shall have to submit a Performance Security Deposit (PSD) within 15 days from the date of issue of work order. Extension of time for submission of PSD beyond 15 days and up to 30 days from the date of issue of work order may be given by the competent authority however a penal interest of 15% per annum shall be charged for the delay beyond 15 days after the date of issue of work order. In case the contractor fails to submit the requisite PSD even after 30 days from the date of issue of work order the contract shall be terminated. The failed contractor shall be debarred from participating in re-tender (if any) for that item. The PSD shall be denominated in Indian Rupees. The PSD should be established in favour of “AIIMS Raipur” through any Schedule Bank with a clause to enforce the same on their local branch at Raipur, which has to be received in the Store Office, Ground Floor, Medical College Building, Tatibandh, Raipur (CG) -492099. The PSD shall be furnished in the form of FDR/DD/BG for an amount covering 3% of the contract value. Validity of the PSD shall be for a period of 60 days beyond entire contract period.
