Technical specifications of IPC software for daily audit and data analysis of infection control parameters

 The software should be able to provide facility to collect, compile and analyze the data against following infection control parameters as per the requirement of the program.

Surveillance for Hospital acquired Infections (HAI) according to CDC/ NHSN

guidelines

- b. Hand hygiene compliance audit according to WHO standards
- c. Bundle care audit as per the checklist of the institute

d. Staff vaccination against HBV

e. Reporting and analysis of needle stick injuries

- f. Environmental (air, water, surface) surveillance and supporting the investigations for disinfectant testing, sterilization controls, MDRO surveillance etc.
- g. Training an education of the HCWs including posttest assessments and generation of participation certificates, access to webinars etc.

The system should be able to collect data by multiple users from different locations of the hospital.

 Data analyzed should be able to represented in graphical format along with generation of location specific reports.

 The system should be user friendly and compatible with Android, iOS and windows based mobile devices and tablets.

The system automatically synchronizes with server immediately after entry and be able to generate the statistics as desired.

Data entry should not require internet connection. System should allow the data to synchronise at a later time when internet facility available.

7. Data security:

Access to any device should be login and password protected.

b. Login access- Data access should be provided based on user type such as officer in-charge, data manager, data editor, data collector. Each login access should have a different data access/analysis capacity.

 Officer in-charge should be in a position to block the functioning of a lost device.

- d. Officer in-charge should be in a position to de-access the account of other users after the tenure of their posting at HICC.
- e. Passwords should be set to automatically expire on the Web application with renewal capabilities

8. Web application

All Master information should be managed by a Central Web application.

Only Administrators should be provided access to Master setup and creation.

 The software should be upgradable and should automatically update with change in the guidelines or new information available.

10. Training of the users and troubleshooting during the usage must be provided by the supplier.
