2. The Chemical Indicator Strip must be compatible with Sterrad NX 50L sterilizer already installed in our institute.
3. As matter of terminal surgical instrument sterilization is very serious and involves with patient safety; all of the above claims by manufacturer must be validated from appropriate authority like CDSCO-India or equivalent Indian Authority/US-FDA/European CE for the intended use in **Sterrad NX 50L Sterilization system** installed in our institute.
4. **At least six months of shelf life of the delivered material must remain from the date of delivery.**
