

VIRAL MENINGITIS RT-PCR Kit Specification

1. Kit should be TaqMan chemistry based multiplex kit.
2. The specificity should be equal to or more than 99%.
3. The sensitivity should be $\geq 95\%$.
4. Should be able to detect Cytomegalovirus (CMV), Human Herpesvirus 6 (HHV6), Human Herpesvirus 7 (HHV7), Epstein-Barr virus (EBV), Varicella Zoster virus (VZV), Herpes Simplex virus 1 (HSV1), Herpes Simplex virus 2 (HSV2), Human Adenovirus (Adv), Parvovirus B-19 (B-19), Mumps virus (MV), Human Enterovirus (HEV), Human Parechovirus (HPeV) individually.
5. The test should be performed with less than 20 μ L of eluted nucleic acid.
6. The kit should be single tube or upto 2 tube based.
7. The Kit should be stable upto 10 repeated freezing/thawing cycles.
8. The kit should have exogenous internal control.
9. The kit should be CDSCO and IVD CE approved and documents should be attached.
10. The literature of kit should be in English and available on company website.
11. The kit should be compatible for all nucleic acid extraction kits.
12. The bulk order will be placed after satisfactory performance of sample kit or supplied kit in "Lot to Lot verification" process.
13. A list of INIs using the product should also be preferably attached.
