### Lab kinetics tube reader-

- 1. The instrument should be an incubating absorbance tube reader.
- 2. The instrument should be able to do single test for fast result for  $(1-3) \beta$ -D Glucan.
- 3. Analysis Method -The instrument should be based on kinetic colorimeter principle and must be compatible to Beta Glucan software (BG software).
