2. Test provides individual identification and quantification for better clinical utility and understanding of all 14 high risk HPV genotypes.
3. Kit should be compatible with Real Time PCR instruments like Himedia Insta 096 Model-LA1073.
4. Application support related to the kit like setting up assay, running tests, standardizing the protocol and analysis and interpretation of the result to be provided by the Manufacturer Company/ brand.
5. Kit should have a min. expiry of 1 year.
6. Kit should have been validated on formalin fixed. Paraffin-embedded (FFPE) tissue.
