- 2. Technical Bid must comprise of complete specification of item and other related document as asked in the NIQ..
- 3. Items provided should be with long expiry
- 4. Rate should be mentioned in words & figures both.
- 5. GST rates applicable on your quoted item may please be confirmed.
- 6. Delivery Schedule- within 30 days from the date of issue of P.O.
- 74. Materials to be delivered at Pharmacy Stores, AIIMS Raipur.
- 8. Brand & Make should be clearly mentioned in offers.
- 9. Lp@0.5% of delayed supply per week or part week for delay of supply of material subject to maximum upto 10% of delayed supply should be deducted.
