The bids in sealed Cover-I must comprise of "Technical Bid" and sealed Cover-II must comprise of "Financial Bid" Both these two cover must be placed in third sealed cover super-scribed with all the details mentioned (Quotation No/Name and Due date of opening must be written on top of the envelop).
2. Technical Bid must comprise of complete specification of item and other related document as asked in the NIQ.
3. Sample will be called from the L1 bidder, if required.
4. Financial bids will be opened only to those bidders whose samples are technically qualified.
5. Rate should be mentioned in words & figures both.
6. GST rates applicable on the quoted item must be mentioned.
7. Delivery Schedule- within 15 days from the date of issue of P.O.
8. No additional documents related to this NIQ will be entertained after NIQ opened.
9. Price should be F.O.R. for Destination basis (i.e. Concerned Department).
