- 1. The interested agencies are required to submit the sealed technical bid and sealed financial bid separately. The bids in sealed Cover -I must comprise of "Technical Bid" and sealed Cover-II must comprise of "Financial Bid" Both these two cover must be placed in third sealed cover super-scribed with all the details mentioned (Quotation No/Name and Due date of opening must be written on top of the envelop).
- 2. Technical Bid must comprise of complete specification of item and other related document as asked in the NIQ.
- 3. Sample will be called from the L1 bidder, if required.
- 4. Financial bids will be opened only to those bidders whose samples are technically qualified.
- 5. Rate should be mentioned in words & figures both.
- 6. GST rates applicable on the quoted item must be mentioned.
