## Terms & Conditions.

- 1. The kits are to be supplied in staggered manner by the supplier.
- 2. The annual requirement of the mentioned kit is 6 kits. The item to be delivered as per schedule as 3 kits per 6 months.
- 3. The interested agencies are required to submit the sealed technical bid and sealed financial bid separately. The bids in sealed Cover -I must comprise of "Technical Bid" and sealed Cover-II must comprise of "Financial Bid" Both these two cover must be placed in third sealed cover super-scribed with all the details mentioned (Quotation No/Name and Due date of opening must be written on top of the envelop).
- 4. Technical Bid must comprise of complete specification of item and other related document as asked in the NIQ.
- 5. Sample will be called from the bidders who are technically qualified, if required.
- 6. Financial bids will be opened only to those bidders whose samples are technically qualified.
- 7. Rate should be mentioned in words & figures both.
- 8. **GST rates applicable** on the quoted item must be mentioned.
- 9. Delivery Schedule- within 15 days from the date of issue of P.O.
- 10. No additional documents related to this NIQ will be entertained after NIQ opened.
- 11. Price should be F.O.R. for Destination basis (i.e. Concerned Department).
