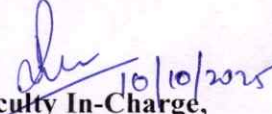

Specification of Orientia tsutsugamushi (Scrub Typhus) IFA IgM Antibody kit

1. The kit should be intended for the simultaneous detection and semi-quantitative determination of IgM class antibody against Orientia tsutsugamushi in human serum or plasma via Indirect fluorescence immunoassay.
2. The kit should utilize 4 strains (Boryong, Gilliam, Karp and Kato) of Orientia tsutsugamushi in a linear of infected cells within each slide well.
3. The kit should provide affinity purified and labeled anti-human IgM (heavy chain) with bovine serum albumin and a counterstain.
4. The literature of kit should be in English.
5. The resulting reactions should be visualized using standard fluorescence microscopy.
