Terms & Conditions.

- 1. The interested agencies are required to submit the sealed technical bid and sealed financial bid separately. The bids in sealed Cover -I must comprise of "Technical Bid" and sealed Cover-II must comprise of "Financial Bid" Both these two cover must be placed in third sealed cover super-scribed with all the details mentioned (Quotation No/Name and Due date of opening must be written on top of the envelop).
- 2. Technical Bid must comprise of complete specification of item and other related document as asked in the NIQ.
- 3. Sample will be called from the bidders who are technically qualified, if required.
- Financial bids will be opened only to those bidders whose samples are technically qualified.
- 5. Rate should be mentioned in words & figures both.
- 6. **GST rates applicable** on the quoted item must be mentioned.
- 7. Delivery Schedule- within 15 days from the date of issue of P.O.
- 8. No additional documents related to this NIQ will be entertained after NIQ opened.
- 9. Price should be F.O.R. for Destination basis (i.e. Concerned Department).
- 10. LD@0.5% of delayed supply per week or part week for delay of supply of material subject to maximum upto 10% of delayed supply should be deducted.
- 11. The bidder participating in the LPC must have a local registered office in Chhattisgarh.
- 12. The GST registration details may please be furnished.

HBV RT-PCR Kit Specification

- The kit protocol should be compatible with CFX-96 and Quantsturio5 (Thermofisher) instrument.
- 2. The kit should be Taqman chemistry based multiplex kit.
- 3. The kit should be CDSCO/ IVD/ CE.
- 4. The kit should be stable upto 05 repeated freezing/thawing cycles
- 5. The Kit should be compatible for all nucleic acid extraction kits.
- 6. The literature of kit should be in English and available on company website.
- 7. The specificity should be equal to or more than 99%.
- 8. The kit should be able to detect all HBV genotypes (A-H).
- 9. The Limit of Detection should be less than 15 IU/ml.
- 10. The linear range of detection can vary from 1.5x10¹ to 7.0x10⁸ IU/ml
- 11. The kit should have exogenous internal control.
- 12. Any quotation having compliance sheet without kit insert will not be entertained, attachment of kits insert is necessary.
- 13. The bulk order will be placed after satisfactory performance of sample kit or supplied kit in "Lot to Lot verification" process.
- 14. The expiry date of kit should be minimum 1 year.
- 15. The compliance sheet should be provided on bidder letter head.

16. There should be no discrepancy in the information provided in the kit insert, on the website of the manufacturer & in the compliance sheet.
