Terms & Conditions.

1. The kits are to be supplied in staggered manner by the supplier.
2. The 1 years requirement of the mentioned kit is 400 tests. The item to be delivered as per schedule as 400 tests per 6 months.
3. The interested agencies are required to submit the sealed technical bid and sealed financial bid separately. The bids in sealed Cover -I must comprise of "Technical Bid" and sealed Cover-II must comprise of "Financial Bid" Both these two cover must be placed in third sealed cover super-scribed with all the details mentioned (Quotation No/Name and Due date of opening must be written on top of the envelop) .
4. Technical Bid must comprise of complete specification of item and other related document as asked in the NIQ.
5. Sample will be called from the bidders who are technically qualified, if required.
6. Financial bids will be opened only to those bidders whose samples are technically qualified.
7. Rate should be mentioned in words & figures both.
8. GST rates applicable on the quoted item must be mentioned.
9. Delivery Schedule- within 15 days from the date of issue of P.O.
10. No additional documents related to this NIQ will be entertained after NIQ opened.
11. Price should be F.O.R. for Destination basis (i.e. Concerned Department).
12. LD@0.5% of delayed supply per week or part week for delay of supply of material subject to maximum upto 10% of delayed supply should be deducted.
13. The bidder participating in the LPC must have a local registered office in Chhattisgarh.
14. The GST registration details may please be furnished.

Dengue Genotype RT-PCR Kit Specification

1. The kit protocol should be compatible with CFX-96 and Quantstudio5 instrument.
2. The kit should be Taqman chemistry based multiplex kit.
3. The kit should be CDSCO/ IVD/ CE approved.
4. The kit should be stable upto 05 repeated freezing/thawing cycles
5. The Kit should be compatible for all nucleic acid extraction kits.
6. The literature of kit should be in English and available on company website.
7. The specificity should be equal to or more than 99%.
8. The kit should be able to detect 4 genotypes-DENV 1-4 individually.
9. The Limit of Detection should be less than or equal to 50 RNA copies/reaction.
10. The kit should have endogenous internal control.
11. Any quotation having compliance sheet without kit insert will not be entertained, attachment of kits insert is necessary.
12. The bulk order will be placed after satisfactory performance of sample kit or supplied kit in "Lot to Lot verification" process.
13. The expiry date of kit should be minimum 1 year.
14. The compliance sheet should be provided on bidder letter head.
