ds DNA ELISA Kits SPECIFICATION:

- Polystyrene micro-well Elisa plate coated with calf thymus dsDNA antigen (12-1x8 wells), with holder in foil package containing desiccants
- Kit should be quantitative, having 5 calibration and 2 controls (one negative and one positive control)
- It should contain all calibrators, controls, sample diluents, wash buffer and conjugate inside the kit.
- All calibrators, controls, sample diluents and conjugate should be in liquid form and ready to use.
- Relative sensitivity and specificity should be equal or more than 90%
- Broad measuring range of up to 100U/ml
- For IVD use.
- Pack size: 1 x 96wells.
- The reagents to be supplied must have expiry of minimum 06-08 months.
