1. The interested agencies are required to submit the sealed technical bid and sealed financial bid separately. The bids in Sealed Cover-I must comprise of “Technical Bid” and in Sealed Cover-II must comprise of “Financial Bid”. Both these two Covers must be placed in third sealed cover superscribed with all the details mentioned.
2. Technical bid must comprise of complete specification of item and other related documents as asked in the NIQ.
3. Samples will be called from the bidders who are technically qualified, if required.
4. Financial bids will be opened of only those bidders are technically qualified.
5. Technical Specification should be attached with rate Quotation.
6. Rate should be mentioned in words & figure both.
7. Taxes/GST, if any (Kindly mention in above table)
8. Delivery schedule: within 45 days from the date of issue of P.O. Delivery period:
9. No additional documents related to this NIQ will be entertained after opening of NIQ.
10. Price should be FOR Destination basis (i.e. Department of Surgical Gastroenterology AIIMS Raipur).

It consists of

1. Hemolok (Homopolymer locking ligation) clip applicator for medium size clips (blue) In laparoscopic surgery-32-34 cm-2 quantity

### **specifications:**

- It should be made of German Steel with Matt finishing with take apart design (must have take apart design)
- It should be Compatible with Medium Homopolymer locking ligation clips (blue) Capable of ligating vessels between 2mm-7mm
- It should be usable through 5 mm laparoscopic port system
- Should provide tactile feedback when locking the clips
- Shaft Length 32-34 cm, Diameter 5 mm
- Should have a large, lightweight rotation knob for one finger allowing 360 Degree rotation of the applier shaft and it should provide tactile feedback when locking
- Applier can be disassembled for effective cleaning and sterilization
- instrument must have a minimum of 1-year warranty

2. Hemolok (Homopolymer locking ligation) clip applicator for medium size clips-11 inch-3 quantity

### **specifications:**

- It should be made of German Steel with Matt finishing
- It should be Compatible with Medium Homopolymer locking ligation clips (Blue) Capable of ligating vessels between 2mm 7mm
- it should open at box lock for easy and thorough cleaning purpose
- Should provide tactile feedback when locking the clips
- Length 11-11.5 inch
- Curved jaw
- Instrument must have a minimum of 1 year warranty

3. Hemolok (Homopolymer locking ligation) clip applicator for medium size clips -8 inch - 2 quantity

### **specifications:**

- It should be made of German Steel with Matt finishing
- It should be Compatible with Medium Homopolymer locking ligation clips (Blue) Capable of ligating vessels between 2mm -7mm
- it should open at box lock for easy and thorough cleaning purpose
- Should provide tactile feedback when locking the clips
- Length 8-8.5 inch
- Curved jaw
- Instrument must have a minimum of 1 year warranty

4. Hemolok (Homopolymer locking ligation) cartridges: 60 quantity specifications:

- It should be made of Non Absorbable Acetal Homopolymer, bio-compatible, inert and radiolucent
- It should be Compatible with Medium Homopolymer locking ligation
- applier (Blue) and Capable of ligating vessels between 2mm-7mm
- One-piece set must comprise of minimum 6 clips. It must have bosses to retain within the applier jaws along with uniform integrated teeth for maximum grip and bow shaped for maximum surface area coverage.
- It must be internally ribbed for better security.

**Terms and conditions:**

1. Should give physical demonstration of all the instruments during technical evaluation /documentation is a part of technical evaluation, if required.
2. All the items should be from the same manufacturing company
3. Item wise selection as L-1 shall not be done.
4. The bidder who has not quoted for all the instruments i.e. the entire set shall not be entertained and bid shall be rejected
5. Full brochure and catalog (of all similar items indicating the items asked for) must be attached in the technical documents
6. All Instruments should have catalog number and brand name engraved on the surface of the instrument.
7. Instruments should have a BIS (part 1, part 2 and part 3)/European CE (with 4 digit notified body number)/USFDA certified and approved for intended use (certificate is to be attached)
8. Instruments should have an MD license from CDSCO as per the new Medical Devices regulations (certificate is to be attached).
