Terms & Conditions.

1. The kits are to be supplied in staggered manner by the supplier.
2. The annual requirement of the mentioned kit is 6 kits. The item to be delivered as per schedule as 3 kits per 6 months.
3. The interested agencies are required to submit the sealed technical bid and sealed financial bid separately. The bids in sealed Cover -I must comprise of "Technical Bid" and sealed Cover-II must comprise of "Financial Bid" Both these two cover must be placed in third sealed cover super-scribed with all the details mentioned (Quotation No/Name and Due date of opening must be written on top of the envelop) .
4. Technical Bid must comprise of complete specification of item and other related document as asked in the NIQ.
5. Sample will be called from the bidders who are technically qualified, if required.
6. Financial bids will be opened only to those bidders whose samples are technically qualified.
7. Rate should be mentioned in words & figures both.
8. GST rates applicable on the quoted item must be mentioned.
9. Delivery Schedule- within 15 days from the date of issue of P.O.
10. No additional documents related to this NIQ will be entertained after NIQ opened.
11. Price should be F.O.R. for Destination basis (i.e. Concerned Department).
12. LD@0.5% of delayed supply per week or part week for delay of supply of material subject to maximum upto 10% of delayed supply should be deducted.
