Technical specification Monolisa HCV Ag-Ab ULTRA V2

1. The test kit must detects Hepatitis C Virus (HCV) antibodies (IgM, IgG, IgA) and core antigen (HCVcAg) using recombinant and synthetic peptides for Core, NS3, NS4, and NS5 regions
2. The quoted kit must be a qualitative enzyme immunoassay 4th Generation ELISA Test.
3. The test kit should able to detect all 8 HCV Genotypes
4. Sample Type- Human Serum or Plasma.
5. 100% Sensitivity
6. 99.67% Specificity
7. The test kit should be provided with colour coded reagents to monitor the procedural steps
8. The complete assay procedure for the ELISA method should be approximately 150 minutes.
9. Shelf life- 24 months when stored at 2-8°C.
10. The kit should be an IVD, FDA approved product with ISO:13485 certified manufacturing.
