2. **Technical Bid must comprise of complete specification of item and other related document as asked in the NIQ..**

3. **Items provided should be with long expiry**

4. Rate should be mentioned in words & figures both.

5. GST rates applicable on your quoted item may please be confirmed.

6. Delivery Schedule- within 30 days from the date of issue of P.O.

7. Materials to be delivered at Pharmacy Stores, AIIMS Raipur.

8. Brand & Make should be clearly mentioned in offers.

9. LD@0.5% of delayed supply per week or part week for delay of supply of material subject to maximum upto 10% of delayed supply should be deducted.

10. Quotation No/Name and Due date of opening must be written on top of the envelop.

11. The GST registration details may please be furnished.

12. Please confirm if there any change (Upward/Reduction) in your **Basic Price structure**. And you are also requested to pass the Input Credit as per the following **Anti Profiteering Clause** of GST. **“Upon Implementation of GST, any reduction in the rate of tax on supply of goods or service or the benefit of input tax credit shall be passed on to AIIMS Raipur by way of commensurate reduction in the prices”**

13. Price should be F.O.R. for Destination basis (i.e. Concerned Department).


14. AIIMS Raipur reserved the rights to place order for full or part quantity to one or more firm. Validity of offer should not be less than 90 days.

15. Supply, Installation and Commissioning will be done by firm (if applicable).

16. The quantity shown in above column are totally tentative, it may be increase and decrease at the time of placement of purchase order.

17. **Other Terms and Conditions:**

- **Supplier must provide technical support in person on site with 48 hrs. of lodging the complaint.**
- **Quotations be called from original manufacturer or their authorized distributor who are in position to provide technical support as mentioned on point no 1.**
- **Supplier will have to set up the antibody on site at AIIMS Raipur within 7 days after the delivery of consignment.**
- **In case of unsatisfactory results/rejected items, supplier must collect the items within 7 days.**
- **In case of unsatisfactory results of the antibody the supplier must replace the antibody within 15 days & only one chance will be given to replace the antibody.**
- **Penalty for delay in delivery of any/all the item within in prescribed time will be imposed on total value of purchase order.**
- **Antibodies should have a shelf life of 1-2 years at the time of supply.**
