2. *Technical Bid must comprise of complete specification of item and other related document as asked in the NIQ.*
3. *Sample will be called from the bidders who are technically qualified, if required.*
4. *Financial bids will be opened only to those bidders whose samples are technically qualified.*
5. *Rate should be mentioned in words & figures both.*
6. **GST rates applicable** on the quoted item must be mentioned.
