Terms and Condition

1. Rate should be mentioned in words & figure both.
2. Taxes/GST, if any (Kindly mention in above table)
3. Delivery schedule: within 30 days from the date of issue of P.O. Delivery period:
4. No additional documents related to this NIQ will be entertained after opening of NIQ.
5. Price should be FOR Destination basis (i.e. Department of Biochemistry), AIIMS Raipur).
6. LD @ 0.5% of delayed supply per week or part thereof for delay of supply of material subject to maximum up to 10% should be deducted. After expiry of delivery period material cannot be accepted without extension of delivery period.
7. Quotation No/Name and due date of opening must be written on top of envelop.

8. GST rates applicable on your quoted item may please be confirmed. **HSN code for item should be clearly mentioned.**
9. Any change (Upward/Reduction) in the Basic Price structure post submission of bid shall be promptly intimated to AIIMS Raipur. You are also required to pass the Input Credit as per the following **Anti Profiteering Clause of GST.**

“Upon Implementation of GST, any reduction in the rate of tax on supply of goods or service or the benefit of input tax credit shall be passed on to AIIMS Raipur by way of commensurate reduction in the prices”.

10. The GST registration details may be furnished.
11. RTGS details required for payment purpose.

12. Payment Clause:

100% Payment shall be made subject to recoveries, if any, by way of liquidated damages or any other charges as per terms & conditions of contract on receipt of goods in good condition/fitting (installation) at the consignee premises and upon the submission of the following documents:

- a. Three copies of supplier's invoice showing contract number, goods description, quantity, unit price and total amount with revenue stamp;
- b. Two copies of packing list identifying contents of each package; Certificate of origin and certificate of guarantee and warranty;
- c. Final Acceptance Certificate in original issued by the authorised representative of the consignee.

13. No part payment will be entertained.

14. Fall Clause :

1. Prices charged for supplies under Rate Contract by the supplier should in no event exceed the lowest prices at which he bids to sell or sells the stores of identical description to any other State Government/DGS&D/Public Undertaking during the period of the contract.
2. If at any time during the period of contract, the prices of tendered items is reduced or brought down by any law or Act of the Central or State government, the supplier shall be bound to inform Purchasing Authority immediately about such reduction in the contracted prices, in case the supplier fails to notify or fails to agree for such reduction of rates, the Purchasing authority will revise the rates on lower side. If there is a price increase for any product after quoting the rates, the bidder will have to supply the item as per quoted rates. This office will not accept any higher rates after wards.
3. If at any time during the period of contract, the supplier quotes the sale price of such goods to any other State Govt./DGS&D and Public Undertakings at a price lower than the price chargeable under the rate contract he shall forthwith notify such reduction to Purchasing Authority and the prices payable under the rate contract for the equipment's supplied from the date of coming into force of such price stands correspondingly reduced as per above stipulation.

Any deviation in the material and the specifications from the accepted terms may liable to be rejected and the suppliers need to supply all the goods in the specified form to the satisfaction/ specifications specified in the Purchase order and demonstrate at their own cost.

15. Arbitration:

If any difference arises concerning this agreement, its interpretation on payment to be made there under, the same shall be settled out by mutual consultation and negotiation. If attempts for conciliation do not yield any result within a period of 30 days, either of the parties may make a request to the Director, AIIMS Raipur to settle the dispute by Sole Arbitrator. Sole arbitrator will be appointed by the Director, AIIMS Raipur. In case of such arbitrator refusing, unwilling or becoming incapable to act or his mandate having been terminated under law, another arbitrator shall be appointed in the same manner from among the panel of three persons to be submitted by the claimant. The provision of Arbitration and Conciliation Act, 1996 and the rule framed there under and in force shall be applicable to such proceedings.

16. Legal Jurisdiction:

The agreement shall be deemed to have been concluded in Raipur, Chhattisgarh and all obligations hereunder shall be deemed to be located at Raipur, Chhattisgarh and Court within Raipur, Chhattisgarh will have Jurisdiction to the exclusion of other courts.

17. **Breach of Contract/Agreement:** In case of breach of any terms and conditions as mentioned above, the Competent Authority will have the right to cancel the contract/agreement without assigning any reasons thereof and nothing will be payable by AIIMS, Raipur. In that event the security deposit shall also stand forfeited.
18. **Subletting of contract:** The firm shall not assign or sublet the contract or any part of it to any other person or party without having prior permission from AIIMS, Raipur, which will be at liberty to refuse if thinks fit. The tender is not transferable.
19. **Guarantee/Warranty, Service, Maintenance:** The tenderers must quote for onsite warranty from the date of completion of the satisfactory installation as certified by concern department. The Warranty charges shall not be quoted separately otherwise the offer shall be summarily rejected.
20. Validity of offer should not be less than 90 days.
21. Supply, installation and commissioning will be done by firm (if applicable).
22. The quantity in above column is totally tentative. It can be increased or decreased at the time of placement of order.
23. AIIMS, Raipur reserve the right to place the order for full or part quantity to one or more firms.
24. The product should be Unused and Brand New.
