FINAL RESULT FOR THE POSTS OF DIETICIAN AND GAS OFFICER

(Reference: Advt. No. Admin/Rec./Regular /Group 'B' & 'C'/ 2016/AIIMS.RPR dated 10.3.2016)

The Computer Based Test (CBT) for recruitment to the posts of **Gas Officer** and **Dietician** along with other Gp 'B' and 'C' posts in AIIMS Raipur was held on 18th & 19th February, 2017 at Raipur, Durg and Bilai. Based on the marks scored by the candidates in the CBT and as per the shortlisting criteria fixed by AIIMS, Raipur, the post and category wise cut-off marks, candidates were shortlisted for Document Verification vide notice dated 24.5.2017.

2. Document verification of the shortlisted candidates for the posts of **Dietician** and **Gas Officer** was held on 29.6.2017 & 30.6.2017 respectively. The result of document verification was uploaded on the website and objections were called from the candidates in respect of the findings of document verification latest by 03.08.2017. Only 01 objection was received which was considered and not accepted.

3. It has already been conveyed vide para 6 of the notice dated 24.5.2017 that only those candidates who are found to fulfil all the eligibility conditions after verification of documents will be considered for final selection and the final select list for the post of Gas Officer and Dietician will be prepared on the basis of marks obtained in the CBT. Accordingly, final merit list on the basis of marks obtained in the CBT has been prepared from amongst the candidates who were found to be eligible for the respective posts after document verification and the same is as given below:-

GAS OFFICER (01-UR)

As no candidate has been found to fulfil the eligibility criteria for the post of Gas Officer, therefore **NO candidate is being recommended for appointment to the post of GAS OFFICER.**
