## RECRUITMENT TO THE POST OF STENOGRAPHER AND UDC IN AIIMS RAIPUR ON REGULAR BASIS – FINAL RESULT

Notice for recruitment to various Gr. 'B' and 'C' posts in AIIMS Raipur on regular basis was issued vide Admin/Rec./Regular/ Group 'B' & 'C'/2016/AIIMS.RPR/ dated 10.03.2016 including 08 vacancies of **Stenographer [ UR-05; 02-OBC; 01-SC]** and 03 vacancies of **UDC [UR-03 ]** 

2. Computer Based Test (CBT) for recruitment to the posts of Stenographer and UDC along with other posts was conducted on 18.02.2017 and 19.02.2017.

3. List of shortlisted candidates for document verification & Skill Test on the basis of marks scored in CBT was declared vide Notice No.Admin/Rec./Regular /Group 'B' & 'C'/ 2016/AIIMS.RPR/ dated 24.5.2017 and Notice No. Admin/Rec./Regular/Group 'B' & 'C'/ 2016/AIIMS.RPR dated 16.07.2017. The result of the Skill Test was declared vide Notice No. 5/1/2017-REctt.AIIMS Rpr. Dated 18.1.2018.

4. As per the provisions mentioned in the notice dated 24.5.2017 and 18.1.2018, <u>only</u> those candidates who have qualified in the Skill Test are considered for final selection and the final select list has been prepared on the basis of marks obtained by the qualified candidates in the Computer Based Test.

5. Accordingly, following candidates are recommended PROVISIONALLY for appointment to the post of **STENOGRAPHER**:-
