RECRUITMENT TO THE POST OF TUTOR/CLINICAL INSTRUCTOR ON DIRECT RECRUITMENT BASIS IN AIIMS RAIPUR FINAL RESULT

Advertisement for filling up **20 Posts [UR-11; OBC-05; SC-03; ST-01]** of **Tutor/Clinical Instructor** on direct recruitment basis in AIIMS Raipur was issued vide Notification No. Admin/Rec./Regular/Group 'A'/2016/AIIMS.RPR dated 14.06.2016. The scheme of the examination was published vide notice dated 28.7.2017 and corrigendum dated 2.8.2017 stipulated conduct of Interview after the CBT.

- 2. Total **1170** applications were received for the aforesaid post. Computer Based Test was held on 26.8.2017 at Raipur in which **576** candidates appeared.
- 3. Objections were called from the candidates after the examination. After considering the objections thoroughly, the questions which were found to be incorrect/ambiguous were ignored and evaluation was carried out with the remaining questions and the final marks were scaled proportionately out of 100. The result of the Computer Based Test was declared vide notice dated 7.12.2017 in which 82 candidates were shortlisted on the basis of the marks obtained by the candidates in the CBT and the short listing criteria fixed by the Competent Authority in AIIMS, Raipur.
- 4. The interview for recruitment to the post of **Tutor/Clinical Instructor** was held on 16th and 17th Dec. 2017 at AIIMS, Raipur. Out of the **82** candidates called for the Interview, **46** candidates appeared.
- 5. As already mentioned in the write up of the result of Computer Based Test declared on 7.12.2017, final Select List will be prepared by giving 80% weightage to marks scored in CBT and 20% to marks scored in the Interview. Accordingly, based on the marks scored in the CBT and Interview, following candidates have been **Selected** PROVISIONALLY for appointment to the post of Tutor/Clinical Instructor in AIIMS, Raipur:-
