RECRUITMENT TO VARIOUS GROUP 'B' POSTS IN AIIMS RAIPUR ON REGULAR BASIS

RESULT OF DOCUMENT VERIFICATION/SKILL TEST

Recruitment notice for filling of various Gp 'B' posts on direct recruitment basis in AIIMS Raipur was issued vide Admin/Rec./Regular/Group 'B'/2017/AIIMS-RPR/966 dated **27.7.2017**. Computer Based Test (CBT) for recruitment was held on **27th-28th Feb. 2018**. Result of the CBT was declared on **27.7.2018**.

2. Candidates shortlisted on the basis of marks obtained in CBT in respect of the posts of **Technical Officer Ophthalmology (Refractionist), Electrocardiograph Technical Assistant, Audiologist and Radiographic Technician Grade I** were called for Document verification followed by Skill Test held on 21.8.2018, 31.8.2018 and 01.09.2018 at AIIMS Raipur.

3. As mentioned in the notice of the recruitment and the write-up of result of CBT declared on 27.7.2018, verification of documents in respect of shortlisted candidates was done to ascertain their eligibility for the concerned post and only those candidates who were found to fulfill the eligibility criteria for the concerned post were allowed to appear in the Skill Test.. The result of the document verification and Skill Test is annexed herewith as **ANNEXURE-I**.

4. Skill test is qualifying in nature and only those candidates who have qualified in the Skill Test and who fulfils the eligibility conditions prescribed for the concerned post, will be considered for final selection which will be based on the marks obtained by them in the CBT. List of final Select List of candidate will be published shortly.
