# RECRUITMENT TO THE POST OF PERSONAL ASSISTANT, STENOGRAPHER AND UDC IN AIIMS NAGPUR ON REGULAR BASIS

#### **FINAL RESULT**

Recruitment notice for filling up the post of **Personal Assistant, Stenographer and Upper Division Clerk (UDC)** on direct recruitment basis in AIIMS Nagpur was issued along with other posts vide Notice No. Admin/Rec./Regular/Group 'B' & 'C'/2018/NAG/530 dated **14.05.2018**. Computer Based Test (CBT) for recruitment to the above posts was held on **22-24<sup>th</sup> July, 2018**. The result of the CBT was declared vide notice dated 30.8.2018. Verification of documents of the shortlisted candidates followed by Skill Test for the abovementioned posts was conducted on 8<sup>th</sup> -9<sup>th</sup> Sept. 2018 at Govt. Polytechnic College, Raipur.
