# RECRUITMENT TO THE POSTS OF STOREKEEPER AND LIBRARIAN GR.III IN AIIMS NAGPUR ON REGULAR BASIS

# FINAL RESULT

Recruitment notice for filling up following posts on direct recruitment basis in AIIMS Nagpur was issued along with other posts vide Notice No. Admin/Rec./Regular/Group 'B' & 'C'/2018/NAG/530 dated **14.05.2018.** Computer Based Test (CBT) for recruitment to these posts was held on **22-24<sup>th</sup> July, 2018**. The result of the CBT was declared vide notice dated 30.8.2018.

2. The shortlisted candidates were called for document verification at AIIMS Nagpur and after verification of documents, the eligibility status of the candidates was uploaded on the website and objections were called from the candidates. Final eligibility status of the candidates after verification of documents is annexed at **ANNEXURE-I.**

As already mentioned in the write-up of result of CBT declared on 30.8.2018, no skill test was held for the above mentioned post and only those candidates who are found to fulfill the prescribed eligibility criteria for the concerned post after verification of their documents are considered for final selection. Final selection has been made on the basis of marks obtained by such eligible candidates in the CBT.
