**RECRUITMENT TO VARIOUS GR. 'B' & 'C' POSTS ON DIRECT RECRUITMENT BASIS**

**RESULT OF THE RE-EXAMINATION FOR THE POST OF TECHNICAL ASSISTANT/TECHNICIAN**

**30 Vacancies**{UR-16;OBC-08;SC-04; ST-02} including 01 PWD] of **Technical Assistant/Technician** were advertised vide Advt No. Admin./Rec./Regular Gr'B' &'C'/2016/AIIMS Raipur dated 10.3.2016 along with other posts. The CBT for this post was conducted on 19.3.2017. The CBT had to be cancelled due to administrative reasons vide notice dated 09.03.2018.

2. Re-examination for the said post was conducted on 31.1.2019 for only those candidates who appeared in the examination held on 19.3.2017. Candidates had the option to choose option of his/her subject i.e. either Medical Lab Technology or OT Techniques before the commencement of the CBT.

Final selection will be made on the basis of marks obtained in the CBT.

11. **IMPORTANT INSTRUCTIONS FOR DOCUMENT VERIFICATION**

All the candidates should note that their candidature for the post is **PROVISIONAL**. Shortlisting for document verification does not entail them any right whatsoever for selection.

**Candidates should bring the following documents in original alongwith one self attested photocopy of each :-**

- (i) Certificate showing date of birth; [10<sup>th</sup>/High School Marksheet indicating date of birth is also accepted as proof of date of birth]
- (ii) Marksheets of all the years of Degree/Diploma alongwith Degree/Diploma Certificate in support their educational qualification;
- (iii) Caste Certificate in the prescribed format if applied under SC/ST/OBC category issued in the prescribed format and by the competent authority;
- (iv) **Experience certificate, if any, duly signed by the competent authority of the Organisation/Institute clearly mentioning the post, period of employment, pay, nature of duties etc. Experience certificate without these details may not be accepted.**
- (v) Those who are in employment must bring No Objection Certificate from their employer;
- (vi) 02 copies of their latest passport size photographs .
- (vii) PWD Certificate in prescribed format if applied under PWD category.

Candidates belonging to OBC category should note that their caste certificate along with the non-creamy layer certificate should be in the prescribed format for employment under the Central Government issued within 3 years of the date of document verification. The format of the caste certificate is available on this website.

Candidates belonging to reserved categories should note that Caste certificates issued in any format other than the prescribed format or signed by any authority other than the prescribed authorities, will not be accepted.

**CANDIDATES WHO FAIL TO APPEAR FOR VERIFICATION OF DOCUMENTS ON THE SCHEDULED DATES OR FAIL TO BRING ANY OF THE DOCUMENTS MENTIONED ABOVE, WILL NOT BE CONSIDERED FOR FINAL SELECTION AND THEIR CANDIDATURE WILL BE SUMMARARILY REJECTED WITHOUT ANY FURTHER NOTICE TO THEM**

12. Candidates should note that their candidature is purely PROVISIONAL at all stages of recruitment and subject to fulfilling all the eligibility criteria prescribed for the post. The candidature of the candidate is liable to be cancelled by the Competent Authority in AIIMS Raipur if at any stage of their appointment it is found that he/she does not fulfill any of eligibility criteria or conditions or if he/she does not belong to the category claimed or if he/she has concealed or given incorrect information which if known earlier, would have rendered him/her ineligible for selection to the respective post.
