**FINAL RESULT**

Recruitment notice for filling up the posts of **Medical Record Technician {20 (UR-11,OBC-06, SC-02; ST-01)}** and **Coding Clerk (UR-03)** on direct recruitment basis in AIIMS Raipur was issued along with other posts vide Notice No. Admin/Rec./Regular/Group 'C' /10/2017/AIIMS.RPR/2156 dated **06.12.2017**. Computer Based Test (CBT) for recruitment to the above posts was held on **27-28<sup>th</sup> Feb.2018**. The result of the CBT was declared vide notice dated 8.8.2018. Verification of documents of the shortlisted candidates followed by Skill Test was conducted on 8<sup>th</sup> -9<sup>th</sup> Sept. 2018 at Govt. Polytechnic College, Raipur. 2. As per the provisions given in the notice of examination, the competent authority at AIIMS Raipur has decided to keep the qualifying marks in Skill Test at 50% or above.

3. The result of the Skill Test is Annexed at **ANNEXURE-I**. No candidate for the post of Coding Clerk qualified in the Skill Test and only 02 candidates for the post of MRT qualified in the skill test.

4 Skill Test was qualifying in nature and qualifying in Skill test does not entail any right of appointment to the candidates. Only those candidates who have qualified in the Skill Test were considered for final selection and the same has been done on the basis of marks obtained by the qualified candidates in the Computer Based Test..
