FINAL RESULT

Recruitment notice for filling up the posts of <u>MULTI REHABILITATION WORKER</u> (<u>PHYSIOTHERAPIST</u>) <u>AND MEDICAL RECORD OFFICER</u> on direct recruitment basis in AlIMS Raipur was issued along with other posts vide Notice No. Admin/Rec./Regular/Group 'B' /12/2017/AIIMS.RPR/2155 dated **06.12.2017**. Computer Based Test (CBT) for recruitment to the above posts was held on **27-28**TH **Feb.2018**. The result of the CBT was declared vide notice dated 8.8.2018. The eligibility status of the candidates after scrutiny of their documents was uploaded on the website vide notice dated 18.1.2019 and objections were called from the candidates.
