**RECRUITMENT OF HEALTH EDUCATOR (SOCIAL PSYCHOLOGIST) IN AIIMS RAIPUR ON  
REGULAR BASIS**

**FINAL RESULT**

Advertisement for filling up 01-UR post of Health Educator (Social Psychologist) was issued along with other posts vide advertisement dated 27.07.2017. The CBT was conducted on 27.02.2018 & 28.02.2018 and result declared on 27.7.2018. Only 5 candidates appeared for the post of Health Educator(Social Psychologist). 03 candidates were shortlisted for document verification. As per the provisions of the advertisement, final selection is to be made from amongst the shortlisted candidates who are found to fulfil the eligibility conditions after verification of documents.

2. Document verification was held on 10.8.2018 & 11.08.2018. After the verification a list of eligible/provisionally eligible and not eligible candidates was published on the website vide notice dated 22.5.2019 and candidates were given opportunity to submit their claim/objections regarding their eligibility status. In response we have received representations from some of the candidates.

3. A Scrutiny Committee was constituted to re-examine the documents submitted by the candidates to decide upon their eligibility for the post as per the essential qualification and experience mentioned in the advertisement. The Committee has found only 01 candidate fulfilling the eligibility criteria. Accordingly the result is as under (in roll no. order) :-

The candidature of the candidate is liable to be cancelled by the Competent Authority in AIIMS Raipur if at any stage of their appointment it is found that he/she does not fulfill any of eligibility criteria or conditions or if he/she does not belong to the category claimed or if he/she has concealed or given incorrect information which if known earlier, would have rendered him/her ineligible for selection to the respective post.
