This is in reference to advertisement No. RC/NF-R/3/2023, dated 17.06.2023 for recruitment to various non-faculty post on direct recruitment basis at AIIMS Raipur.

- 2) Computer Based Test (CBT) for the above mentioned posts was held on 04th, 5th September 2023. The result of the CBT was declared vide notice No. RC/NF-R/3/2023 dated 11.12.2023. The list of shortlisted candidates for skill test was also uploaded through the above mentioned notice.
- 3) The skill test (Qualifying in nature) for the above mentioned posts was conducted on 29.08.2024 at Govt. Girls Polytechnic, Raipur. Subsequently, documents of shortlisted candidates were re-scrutinized by the Scrutiny Committee.
