Failure to submit the required documents within the stipulated period shall lead to cancellation of candidature without any prior notice, and no further correspondence in this regard shall be entertained.

The candidature of the candidate is liable to be cancelled by the Competent Authority in AIIMS Raipur if at any stage of their appointment it is found that he/she does not fulfil any of eligibility criteria or conditions or if he/she does not belong to the category claimed or if he/she has concealed or given incorrect information which if known earlier, would have rendered him/her ineligible for selection to the respective post.
