This is in reference to Advertisement Notice No. 278/2025 dated 11.07.2025 published by AIIMS Delhi for the Common Recruitment Examination (CRE)-2024 for recruitment to various posts on a Direct Recruitment basis at AIIMS Raipur and other Central Government Institutes/Bodies.

1. The Computer Based Test (CBT) for the above-mentioned advertisement was conducted on 25th and 26th August 2025 at various centres across the country.
2. Based on the merit obtained in the CBT, candidates have been shortlisted category-wise and allotted AIIMS Raipur for document verification and further appointment processes.
