**NOTICE OF RESULT OF SELECTION OF THE WAITLISTED CANDIDATES FOR
RECRUITMENT TO THE POST OF PSYCHIATRIC SOCIAL WORKER AT AIIMS RAIPUR
THROUGH CRE-2024**

1. This is in reference to the advertisement Notice No.171/2025, dated 07/01/2025, published by AIIMS Delhi for COMMON RECRUITMENT EXAMINATION (CRE)- 2024 for recruitment to various posts on Direct Recruitment basis at AIIMS Raipur & Other Central Govt Institutes/bodies and subsequent CBT and skill test.
2. Based on the order of merit in the result of CBT, waitlisted candidates have been shortlisted category-wise for document verification
3. Document verification was conducted for all the shortlisted candidates on 14.10.2025 in the premises of AIIMS Raipur vide notice No. RC/CRE/2025, dated 30.09.2025 and Notice No. RC/CRE/2025, dated 13.10.2025.
4. Based on the recommendation of document verification, the final result of selection for provisional appointment in various posts in the order of merit was declared vide Notice No. RC/CRE/2025, Dated 20.11.2025.
5. Result for the post of Psychiatric Social Worker was withheld subjected to the outcome of O.A. No 3862/2025. Pursuant to the order of principle bench of CAT dated 18.04.2026, the final result of eligibility cum selection for provisional appointment to the said post in the order of merit is placed in Annexure-I.
6. Candidate should note that their candidature is purely PROVISIONAL at all stages of recruitment and subject to fulfilling all the eligibility criteria prescribed for the post as clearly mentioned in the advertisement and further notices related to Common Recruitment Examination (CRE-2024).
7. All provisionally eligible candidates are hereby required to submit their deficient documents or representations within 15 days from the date of declaration of the result. Failure to submit the required documents within the stipulated period shall lead to cancellation of candidature without any prior notice, and no further correspondence in this regard shall be entertained.
8. The candidature of the candidate is liable to be cancelled by the Competent Authority in AIIMS Raipur if at any stage of their appointment it is found that he/she does not fulfil any of eligibility criteria or conditions or if he/she does not belong to the category claimed or if he/she has concealed or given incorrect information which if known earlier, would have rendered him/her ineligible for selection to the respective post.
9. Offer of appointment to the selected candidates will be issued shortly. Candidates are advised to regularly check their registered email ID and visit the website of AIIMS Raipur (www.aiimsraipur.edu.in) for further updates.
