- ii. For such quoted items, the bidder shall be fully responsible for: satisfactory performance of the reagents, provision of all required accessories/consumables, internal and external quality control (including participation in worldwide EQAS/Inter-laboratory comparison, where applicable), and achievement of the quality targets as per the lab policy. The bidder MUST PROVIDEworld wide data for all parameters.
- iii. If the bidder (manufacturer/OEM or its authorised agent) has any item of its own make corresponding to an item mentioned in Annexure-3, the bidder must quote only its own make for that item.
- iv. If, at any time during the period of the Rate Contract, the bidder or its principal/OEM introduces or obtains regulatory approval for reagents of its own make corresponding to any test/item covered under Annexure-3, the following shall apply:
  - a. The bidder shall be OBLIGED to supply its own-make reagents for that/those item(s) from the date of such availability or approval.
  - b. Such own-make reagents shall be supplied at a price not higher than the rate already quoted and finalised in the Rate Contract for that item and on the same commercial terms and conditions (including warranty, QC responsibilities, free of cost calibrators or controls, uptime obligations, penalties, etc.) as applicable to all other items under the Rate Contract.
  - c. No separate price revision or additional financial burden shall be admissible on account of such changeover to own-make reagents.
  - d. For such items, the bidder shall be fully responsible for: satisfactory performance of the reagents, provision of all required accessories/ consumables, internal and external quality control (including participation in worldwide EQAS/Inter-laboratory comparison, where applicable), and achievement of the quality targets as per the lab policy. The bidder MUST PROVIDE world wide data for all
