All India Institute of Medical Sciences (AIIMS) Raipur invites sealed tender for "Supply, Installation, Testing & Commissioning Of 100mbps Internet Leased Line connection" as per details and specifications shown in the Annexure-I on the following terms & conditions:

#### **TERMS&CONDITIONS:**

- **1.** Tender document may be downloaded from AIIMS web site <a href="www.aiimsraipur.edu.in">www.aiimsraipur.edu.in</a> (for reference only) and CPPP site <a href="https://eprocure.gov.in/eprocure/app">https://eprocure.gov.in/eprocure/app</a> as per the schedule as given in CRITICAL DATE SHEET.
- **2.** Bid shall be submitted online at CPPP website: https://eprocure.gov.in/eprocure/app.
- **3.** Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.
- 4. Tenderer who has downloaded the tender from the **AIIMS** web site www.aiimsraipur.edu.in and Central Public Procurement Portal (CPPP) eProcurement website https://eprocure.gov.in/eprocure/appshall not tamper/modify the tender form including downloaded price bid template in any manner. In case if the same is found to be tempered/modified in any manner, tender shall be completely rejected and EMD would be forfeited and tenderer is liable to be banned from doing business with AIIMS Raipur.
- 5. Manual bid shall not be accepted in any circumstance.
- **6.** The complete bidding process in online bidding, Bidder should be possession of valid Digital Signature Certificate (DSC) for online submission of bids. Prior to bidding DSC need to be registered on the website mentioned above.
- 7. Tenderers are advised to follow the instructions provided in the 'Instructions to the Tenderer for the e-submission of the bids online through the Central Public Procurement Portal for e Procurement at <a href="https://eprocure.gov.in/eprocure/app">https://eprocure.gov.in/eprocure/app</a>.
- **8. Quotations should be valid for 180 days** from the tender due date i.e. tender opening date. The bidder should clearly indicate the period of delivery.
- **9.** In the event of withdrawal / revocation of the tender before the date of acceptance, strict action/ blacklisting of firm as per Undertaking given by the bidder for the EMD exemption.
- **10.** Director, AIIMS, Raipur reserves the right to cancel the tender at any time without assigning any reason there.
- 11. The place of delivery will be Medical college building, 1st floor, AIIMS, Raipur.
- **12.** No installation and uprooting charges will be paid.

- **13.** Any freight and cartage charges will be borne by the contractor for delivering the items.
- **14.** On satisfactory performance and completion of the contract in all respects, the security money will be refunded to the contractor without any interest.
- **15.** The details of enclosures should be numbered and total pages should be mentioned in the forwarding/ offer letter.
- **16.** Supplier /Service Providers can visit the existing Server room, medical college, 1<sup>st</sup> floor of AIIMS Raipur.
- 17. In case of disputes, the same shall be referred to any arbitrator appointed by the Director AIIMS Raipur and the decision of the arbitrator will be final and binding to both the parties. The venue of the arbitration shall be Raipur.
- 18. Tenderer must provide evidence of having supplied/ Installed in government hospital / reputed private hospital organizations in India similar nature of items of at least Rs 4,00,000/- of contract value in the last three years and the copy of the same should be uploaded.
- **19.** The firm should be registered and should have the average annual turnover of the bidder in the last three financial years should not be less than **Rs 8,00,000/-** of contract value. Copies of authenticated balance sheet for the past three financial years should be uploaded.
- **20.** The tender document must be accompanied by copy of PAN, Certificate of firm/company registration, GST registration (Sales tax).
- **21.** The quantity shown against each item is approximate and may vary as per demand of the Institute at the time of placement of order.
- 22. The bidder must be able to provide the product/items/Service within specified time period as prescribed in the Purchase Order, failing which strict action will be taken including blacklisting of the Bidder. Furthermore on completion of the stipulated time period, Purchase Order will be cancelled and award will be given to another qualified bidder with the negotiated terms & conditions as per Institutes norms.
- 23. In the event of any dispute or difference(s) between the vendee (AIIMS Raipur) and the vendor(s) arising out of non-supply/ installation of material or supplies not found according to the specifications or any other cause what so ever relating to the supply or purchase order before or after the supply has been executed, shall be referred to the Director/AIIMS/Raipur who may decide the matter himself or may appoint arbitrator(s) under the arbitration and conciliation Act 1996. The decision of the arbitrator shall be final and binding on both the parties.
- **24.** The place of arbitration and the language to be used in arbitral proceedings shall be decided by the arbitrator.
- **25.** All disputes shall be subject to Raipur Jurisdiction only.
- 26. AIIMS Raipur reserves the rights to accept/reject any bid in full or in part or accept any bid other than the lowest bid without assigning any reason thereof. Any bid containing incorrect and incomplete information shall be liable for rejection.
- **27.** The Tender/Bid will be opened online at website <a href="https://eprocure.gov.in/eprocure/app">https://eprocure.gov.in/eprocure/app</a> on Store office at AIIMS Raipur Premises at the time of bid opening.
  - i) Only those financial bids will be opened whose technical bids are found suitable by the expert committee appointed for the concerned instrument/equipment.
  - ii) No separate information shall be given to individual bidders. In incomparable situation, the committee may negotiate price with the technically and financially qualified bidder before awarding the bid.

**28.** Copies of original documents defining the constitution or legal status, place of registration and principal place of business of the company or firm or partnership, etc.

#### 29. Award of Contract

The Purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has bided the lowest evaluated quotation price.

- i) Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.
- ii) The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the bid validity period. The terms of the accepted bid shall be incorporated in the purchase order.
- **30.** The competent authority reserves all rights to reject the goods if the same are not found in accordance with the required description / specifications/quality.
- **31. Earnest Money:** EMD Declaration form as per Annexure III.

#### **Other Terms & Conditions:**

#### 1. Performance Security Deposit (PSD):

- a. The successful bidder shall have to submit a Performance Security Deposit (PSD) within 30 days from the date of issue of Letter of Award (LOA). Extension of time for submission of PSD beyond 30 days and up to 60 days from the date of issue of LOA may be given by the competent authority to sign the contract agreement however a penal interest of 15% per annum shall be charged for the delay beyond 30 days. i.e. 31st day after the date of issue of LOA. In case the contractor fails to submit the requisite PSD even after 60 days from the date of issue of LOA the contract shall be terminated duly forfeiting the EMD and other dues, if any payable against the contract . The failed contractor shall be debarred from participating in re-tender (if any) for that item.
- **b.** Successful supplier/firm should submit Performance Security Deposit in favour of "AIIMS, Raipur" to be received in the Store Office, Medical College Building, Tatibandh, Raipur (C.G) Pin-492099 before the date of commencement of supply or 30 days from the date of acceptance of the LOA, whichever is earlier. The Performance Security Deposit shall be furnished in the form of FDR/DD/Bank Guarantee or performance guarantee bond as per proforma given in the tender documents, for an amount covering 3% of the contract value.
- **c.** The Performance Security Deposit should be established in favour of "AIIMS Raipur" through any Schedule Bank with a clause to enforce the same on their local branch at Raipur.
- **d.** Validity of the Performance Security Deposit shall be for a period of 60 days beyond entire contract period.

#### 2. Delivery& Installation:

- a. The successful bidders should strictly adhere to the following delivery schedule; supply should be effected within **15 days** from the receipt of Purchase order and this clause should be strictly adhere to failing which administrative action as deemed fit under rules will be taken against the defaulter. Purchase Order will be placed as per requirement of institute.
- b. If the supplier fails to deliver any or all of the goods or fails to perform the service within the time frame(s) incorporated in the tender, the Purchaser shall, without prejudice to other right and remedies available to the Purchaser under the tender, deduct from the quoted price, as liquidated damages, a sum equivalent to 0.5% per week of delay or part thereof on delayed supply of the quoted price. Once maximum 10% of value of contract for delayed supply is reached, Purchaser may consider termination of the tender.

#### 3. Right of Acceptance:

AIIMS, Raipur reserves the right to accept or reject any or all tenders/quotations without assigning any reason there of and also does not bind itself to accept the lowest quotation or any tender. AIIMS, Raipur also reserves the rights to accept all the equipment/instruments in the given tender or only part of it in any given schedule without assigning any reason.

#### 4. Validity of the bids:

The bids shall be valid for a period **of 180 days** from the date of opening of the tender. This has to be so specified by the tenderer in the commercial bid which may be extended, if required.

#### 5. Risk Purchase & Recovery of sums due:

- Failure or delay in supply of any or all items as per Requisition / Purchase Order, Specification or Brand prescribed in the tender, shall be treated as 'non-compliance' or 'breach of contract' and the order in part of full be arranged from alternative source(s) at the discretion of the hospital authority and the difference in price can be recovered from the tenderer.
- The amount can be recovered from any of his subsequent / pending bills or security Deposit.
- In case the sum of the above is insufficient to cover the full amount recoverable, the contractor shall pay to the purchaser, on demand the remaining balance due.

#### 6. **Communication of Acceptance:**

AIIMS, Raipur reserves all right to reject any tender including of those tenderers who fails to comply with the instructions without assigning any reason whatsoever and does not bind itself to accept the lowest or any specific tender. The decision of this Institute in this regard will be final and binding.

#### 7. Insolvency etc.:

In the event of the firm being adjudged insolvent or having a receiver appointed for it by a court or any other under the Insolvency Act made against them or in the case of a company the passing any resolution or making of any order for winding up, whether voluntary or otherwise, or in the event of the firm failing to comply with any of the conditions herein specified AIIMS, Raipur shall have the power to terminate the contract without any prior notice.

#### 8. Force Majeure:

- a. If, at any time during the subsistence of this contract, the performance in whole or in part by either party of any obligation under this contract is prevented or delayed by reasons of any war or hostility, act of public enemy, civil commotion, sabotage, fire, floods, exception, epidemics, quarantine restriction, strikes lockout or act of God (hereinafter referred to as events) provided notice of happening of any such eventuality is given by party to other within 21 days from the date of occurrence thereof, neither party hall by reason of such event be entitled to terminate this contract nor shall either party have any claim for damages against other in respect of such non-performance or delay in performance and deliveries.
- b. Further, that if the performance in whole or in part of any obligation under this contract is prevented or delayed by reason of any such event for a period exceeding 60 days, AIIMS, Raipur may, at list option to terminate the contract.

#### 9. Breach of Contract:

In case of breach of any terms and conditions as mentioned in agreement/contract, the Competent Authority, will have the right to cancel the contract without assigning any reasons thereof and nothing will be payable by AIIMS, Raipur. In that event the security deposit shall also stand forfeited.

#### 10. **Subletting of Contract**:

The firm shall not assign or sublet the contract or any part of it to any other person or party without having prior permission in writing of AIIMS, Raipur, which will be at liberty to refuse if thinks fit. The tender is not transferable.

#### 11. Right to call upon information regarding status of contract:

AIIMS, Raipur will have the right to call upon information regarding status of contract at any point of time.

#### 12. Terms of payment:

- a. One time payment would be made for actual supply/ Installation taken and no claim in this regard should be entertained.
- b. Quarterly payment will be done for the bills received duly certified from IT Department for 1 year & subsequently up to 5 years on approval from competent authority.
- c. Quarterly Bill submitted by Vendor should have detailed usage of Bandwidth & Data by AIIMS Raipur from respective network. No bills will be accepted without having data usage details.
- d. Three copies of supplier's invoice showing contract number, goods description, quantity, unit price and total amount with revenue stamp;
- e. Two copies of delivery challan identifying contents of each package;
- f. Where there is a statutory requirement for tax deduction at source, such deduction towards income tax and other tax as applicable will be made from the bills payable to the supplier at rates as notified from time to time.

#### 13. Good & Service Tax:

- **a.** GST rates applicable on the quoted item may please be mentioned in the bid document.
- **b.** It may be confirm if there is any (Upward/Reduction) in the Basic Price structure. Bidders are required to pass the Input Credit as per the following Anti Profiteering Clause of GST.
  - "Upon Implementation of GST, any reduction in the rate of tax on supply of goods or service or the benefit of input tax credit shall be passed on to AIIMS Raipur by way of commensurate reduction in the prices".
- **c. HSN Code** for each item should be clearly mentioned.

#### 14. Fall Clause:

- 1. Prices charged for supplies under Rate Contract by the supplier should in no event exceed the lowest prices at which he bids to sell or sells the stores of identical description to any other State Government/DGS&D/Public Undertaking during the period of the contract.
- 2. If at any time during the period of contract, the prices of tendered items is reduced or brought down by any law or Act of the Central of State government, the supplier shall be bound to inform Purchasing Authority immediately about such reduction in the contracted prices, in case the supplier fails to notify or fails to agree for such reduction of rates, the Purchasing authority will revise the rates on lower side. If there is a price increase for any product after quoting the rates, the bidder will have to supply the item as per quoted rates. This office will not accept any higher rates after wards.
- 3. If at any time during the period of contract, the supplier quotes the sale price of such goods to any other State Govt./DGS&D and Pubic Undertakings at a price lower than the price chargeable under the rate contract he shall forthwith notify such reduction to Purchasing Authority and the prices payable under the rate contract for the equipment's supplied from the date of coming into force of such price stands correspondingly reduced as per above stipulation.
- 4. Any deviation in the material or specifications from the accepted terms may liable to be rejected and the suppliers need to supply all the goods in the specified form to the

satisfaction/ specifications specified in the Purchase order and demonstrate at the their own cost.

#### 15. Arbitration:

If any difference arises concerning this agreement, its interpretation on payment to the made there under, the same shall be settled out by mutual consultation and negotiation. If attempts for conciliation do not yield any result within a period of 30 days, either of the parties may make a request to the Director, AIIMS Raipur to settle the dispute by Sole Arbitrator. Sole arbitrator will be appointed by the Director, AIIMS Raipur. The provision of Arbitration and Conciliation Act, 1996 and the rule framed there under and in force shall be applicable to such proceedings.

#### 16. Option Clause/ Tolerance Clause:

If essentially stipulated by indenting authority, which is duly approved by competent authority of AIIMS Raipur. Then purchaser retains the right to place the repeat order for an additional quantity with the same rate and terms of contract. This clause should be a part of bid document and the contract.

#### 17.Legal Jurisdiction:

The agreement shall be deemed to have been concluded in Raipur, Chhattisgarh and all obligations hereunder shall be deemed to be located at Raipur, Chhattisgarh and Court within Raipur, Chhattisgarh will have Jurisdiction to the exclusion of other courts.

**18.** Rate wise comparison of the quotes will be made and L1\* will be decided on Total Amount. In this context, final decision of the committee will be binding on all and no claim in this regard will be entertained. The quantity indicated is tentative and may vary, and any decision in this regard by Director AIIMS Raipur shall be final.

#### 19. Contract Period:

Contract will be initially for 1 year & can be extended on yearly basis for 5 years on mutual consent with the approval of competent authority. AIIMS Raipur reserves the right to cancel the contract/ request for Upgrade or terminate the connection at any time from the date of installation & commissioning of the lease line with the approval of competent authority.

#### **SPECIAL CONDITION:-**

- 1. The firm must be ISP/ authorized distributor of Internet provider and the firm should hold valid ISP license for providing internet services as per DOT norms.
- 2. Only Class A or Class B IPV4 must be provided along with the lease line.
- 3. Link should be given in ring form so that uptime is 24x7 even one line is down.
- 4. Should have reputation and experience of over last 5 years as Internet service provider.
- 5. Should have full facility for testing and logging of bandwidth & data usage for the dedicated lease line connection.
- 6. The firm should maintain color code of all medical gases cylinders.
- 7. The firm should not demand separate security, caution money & rent/ maintenance charge, transport charges and holding charges on gas cylinders.
- 8. One time installation charges will be paid & Quarterly payment will be done on bills received with data usage.
- 9. The firm will be responsible for routine check and maintenance at no extra cost, PM report to be submitted every month.
- 10. Director AIIMS Raipur reserves the right to select different vendors if the lowest rates for different ISP's differ among bidders.
- 11. Bidder should quote separately for installation & commissioning as one time charge & yearly charges to be paid quarterly.

#### 12. Service Level Agreement & Non Performance charges:

AIIMS expects very high availability and reliability of the ILL through out its leasing to AIIMS. The expected support SLAs during leased period are as per below:

- a) Mean Time to Resolve (MTTR): Service Levels Last Mile Complaints: 4 clock Hrs. Backbone/System/HW Faults: 8 clock Hrs.
- b) Link Availability: 99% calculated on 24x7 basis for the every month.
- c) Packet Losses: Less than 1% (Average over 1000 Ping) at any given point of time to any part of globe.
  - d) Latency: Less than 50 ms from AIIMS, Raipur to ISP tier 1 peering point.

The vendors shall provide reports from their Network Monitoring System (NMS) along with calculations of SLAs on monthly basis for release of payment.

#### 13. Non-Performance Penalty:

In case of any problem reported, the same has to be attended & resolved as per Service level Agreement (SLA) mentioned above. In case of violations of SLAs, the penalty applied shall be as per below:

- 1. For every hour of delay in problem resolution, non-performance penalty of 0.5% of total contract value shall be applied and deducted.
- 2. For link uptime less than 99%, non-Performance penalty on monthly recurring charges shall be applied as per the table below.

#### **14. Acceptance Certificate**

On successful completion of acceptability test for 15 days and after AIIMS Raipur is satisfied with the accuracy and completeness of the performance of the Internet Bandwidth, the acceptance certificate signed by the representative of AIIMS Raipur and representative of the Vendor will be issued. The date on which such certificate is signed shall be deemed to be the date of successful commissioning of the Internet Bandwidth.

# <u>Technical Specifications for Supply, Installation, Testing & Commissioning Of</u> 100mbps Internet Leased Line connection

**SCOPE OF WORK** Tender for Supply, Installation, Testing & Commissioning of 100mbps Internet Leased Line

- a) To provide 100 Mbps Internet leased line connectivity on uncompressed, unshared leased line (Optical Fibre Cable) (1:1) at AIIMS Raipur on rental basis with last mile connectivity.
- b) This includes installation, commissioning, testing & maintenance of the complete link initially for one year from the date of installation, which can be extended on the basis of satisfactory services provided on year to year basis for a period of maximum five years with mutual consent and rates, terms & conditions mutually agreed at the time of extension. The connectivity will be through dedicated Internet leased line with last mile connectivity service.
- c) The hardware and software required for the establishment of fully functional leased lines will be provided by the bidders on rental basis. The minimum guaranteed bandwidth required from the Bidder is 100 Mbps for the leased line.
- d) The vendors shall supply and install the equipments required for provisioning of the required links at medical college building, 1 st floor; and integrate and test systems to meet AIIMS requirements.
- e) Within one week after receipt of LOI/PO, the vendor has to submit the detailed project schedule with proper timelines and resource deployment. The same shall also cover the requirement from AIIMS side.
- f) Any change that is needed to be carried out in the existing setup shall be carried out after approval by the competent authority of AIIMS. The same shall be informed in advance so as to plan the downtime/impact to the end users. The work shall be carried out as per AIIMS compliance and requirements communicated to the vendors from time to time.
- g) Vendors shall ensure that the proposed solutions/components/services are as per applicable regulations in India. The vendor shall be responsible for implementing and maintaining the implemented solutions/services as per applicable regulations in India.
- h) Vendors shall submit architectural design of link built-up. The links must not be overlapped with other existing Internet Links to AIIMS.

#### **Instructions for Online Bid Submission:**

The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

More information useful for submitting online bids on the CPP Portal may be obtained at: https://eprocure.gov.in/eprocure/app.

#### REGISTRATION

- 1) Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL: https://eprocure.gov.in/eprocure/app) by clicking on the link "Online bidder Enrollment" on the CPP Portal which is free of charge.
- 2) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 3) Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 4) Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / nCode / eMudhra etc.), with their profile.
- 5) Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.

- 4) Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS / RAR / DWF/JPG formats.
