01. As a supplier participating in government tenders/ contracts, you must maintain the highest standards of ethical conduct and transparency, as laid down in the Code of Integrity in Public Procurement and other provisions in the relevant Tender Documents/Contracts.

02. Due to your misdemeanour mentioned below relating to the Tender Document/ Contract referred to above, you are proposed to be debarred from participation in all tenders/ contracts of [Govt. of India/ Ministry/ Department/ CPSE/ Organization] for a period not exceeding two years.

Despite a show- cause notice letter already issued by the Store Department in this regard. In compliance with Point Nos. 3, 4, and 9 of "Other Terms and Conditions" mentioned in the tender document and Point No. 5/C of Letter No. F.1/20/2018-PDP – *Guidelines on Debarment of Firms from Bidding*, your firm is hereby debarred for 2 years from AIIMS Raipur.

Furthermore, the Performance Security Deposit (PSD) submitted by your firm is being forfeited and transferred to AIIMS Raipur's account for violating the terms and conditions of the contract agreement. Also, AIIMS Raipur will inform other departments about the same..
