IMPORTANT NOTICE

1. This is with reference to AIIMS Raipur Advt. No. RC/NF-C/H/2023/879 dated 02.02.2023 regarding recruitment to the post of Medical Physicist (Nuclear Medicine), Nuclear Medicine Technologist and Cath Lab Technician on contractual basis.

2. As given in the said advertisement, the selection for the post of Medical Physicist (Nuclear Medicine) will be done on the basis of performance of candidates in the Interview. For the post of 'Nuclear Medicine Technologist' and 'Cath Lab Technician', selection process i.e. written test notified in the said advertisement (in Section II, point No. 2) is partially revised as under:-

(c)	Maximum marks	60 (one mark for each correct answer)
Other contents of the written test scheme shall remain the same as given in the advertisement.		

3. The window for submission of application for the post of Medical Physicist (Nuclear Medicine) and Nuclear Medicine Technologist **reopens till 21.03.2023**. All eligible and interested candidates for these posts may apply and submit their application as per the instructions given in the above-mentioned advertisement so as to reach Recruitment Cell, AIIMS Raipur on or before **27.03.2023**.

4. **Written test for Cath Lab Technician** : The written test for the post of Cath Lab Technician will be held on **20.03.2023** as per the above-mentioned revised test scheme. Reporting time for candidates will be 10:00 AM on 20.03.2023 at Committee Room, First Floor, Medical College Building (Gate No. 5), AIIMS Raipur (CG). The list of candidates whose applications have been received is given at **Annexure-1**.

5. As given in the above-mentioned advertisement (in Section II, point No. 4 on page 3), document verification will be carried before the written test to determine the eligibility of candidates. Only eligible candidates will be allowed to appear for the written test. Therefore, candidates must bring their relevant original degree/diploma/certificates for verification. Candidates must ensure that they fulfil the prescribed eligibility criteria as on the last date of application i.e. 28.02.2023, failing which their application/candidature will be summarily rejected and the **concerned candidate shall be solely responsible** for this.
