**Notice for the post of  
Dissection Hall Attendants and Hospital Attendant Grade-III**

{Ref Rect. Advt. No. RC/NF-R/3/2023, dated 17.06.2023}

This is in reference to the advertisement No. RC/NF-R/3/2023, dated 17.06.2023 published for recruitment to the post of **Dissection Hall Attendants** and **Hospital Attendant Grade-III** along with other non-faculty Group 'A' 'B' and 'C' post Direct Recruitment basis at AIIMS Raipur.

- 1) Computer Based Test (CBT) for recruitment to the above mentioned posts was held on 05.09.2023. The result of the CBT was declared vide notice No. RC/NF-R/3/2023, dated 11.12.2023 and document verification of shortlisted candidates (**Annexure-I**) was held on 15<sup>th</sup> December 2023 in the premises of AIIMS, Raipur.
- 2) We received some representations from the candidates regarding the above mentioned result. We have examined the same and found name of some candidates were missed out in the list of shortlisted candidates due to some inadvertent/technical error.
- 3) Document Verification of the **additional candidates** and Medical Examination of PwBD candidates who have secured the defined cut off marks in their respective category mentioned in the is scheduled to be held in the premises of AIIMS Raipur as mentioned in the **Annexure-II**:

**Please read the following instructions carefully as your document verification will be subject to fulfilment of the following:-**

1. Candidates should bring the following documents in **original along with one self-attested photocopy** of each:-
  - I. Printout of online application form.
  - II. Certificate showing date of birth; [10th/High School Marksheet indicating date of birth is also accepted as proof of date of birth]
  - III. Marksheet and certificate of 12th (Higher Secondary)
  - IV. **Marksheets** of all the years of qualifying Degree/Diploma **along with Degree/ Diploma Certificate** in support their educational qualification;
  - V. Valid certificate of registration (if, applicable)
  - VI. Caste Certificate in the prescribed format if applied under SC/ST/OBC/EWS/category issued in the prescribed format and by the Competent Authority.
  - VII. PwBD Certificate in prescribed format and issued by Competent Authority, if applied under PwBD category.
  - VIII. Experience certificate, duly signed by the Competent Authority of the Organization/Institute/Hospital clearly mentioning the post, period of employment etc. Experience certificate without these details may not be accepted.

**Note:**

(i) Only full time experience after obtaining essential educational qualification will be considered.

(ii) Experience will be counted as on last date of submission of online application form.

IX. Those who are in employment under Central /State Government/Public Sector Undertaking/ Autonomous institute, must bring **No Objection Certificate** from their employer.

X. Any other relevant documents.

2. OBC-NCL candidates applying for the vacancies reserved for them must produce OBC-NCL certificate based on the income for the Financial Year 2022-23, 2021-22 and 2020-21. In other words, date of issue of OBC-NCL certificate should be in the Financial Year 2023-24. It should be in the format prescribed by the Govt. of India.
3. EWS category candidates are required to produce 'Income and Asset' certificate valid for the year 2023-24 as per the format given in DoPT O.M. dated 31.01.2019.
4. Benefits to PwBD will be allowed in accordance with the Rights of Persons with Disabilities Act, 2016 and Rules framed there-under. Benefit under the PwBD category will be admissible to only those who suffer from not less than 40% of specified disability. Such PwBD candidates have to submit a Disability Certificate issued by the competent authority in the prescribed format.
5. Specified/suitable category of disabilities for the posts for PwBD candidates will be as per the Ministry of Social Justice and Empowerment, Govt. of India, Notification No. 38-16/2020-DD-III dated 04.01.2021 and as decided by the appointing authority considering the functional/physical requirements of the post. The Institute may verify the authenticity of the certificate of disability and examine suitability of the candidate in terms of functional requirements before appointment. In this regard, the decision of the Institute will be final.
6. Candidates belonging to reserved categories should note that Caste certificates issued in any format other than the prescribed format or signed by any authority other than the prescribed authorities, will not be accepted.
7. **Candidate may note that on scheduled date of document verification/Medical Examination failure to attend the Document Verification/Medical Examination or failure to bring all the above mentioned documents in original will lead to cancellation of their candidature from the concerned post. No representation in this regard will be entertained. Request for change in date of document verification/Medical Examination will not be entertained.**
8. Your Document Verification/Examination of Disability may be spilled over to the next day depending upon the number of candidates present on the scheduled day of Document Verification. Therefore, **you should be prepared to be available for Document Verification for the next day also, if required.**
9. Candidates must note that their candidature is purely PROVISIONAL and subject to fulfilling the eligibility criteria and other terms mentioned in the advertisement dated 17.06.2023. During document verification, if candidate is not found eligible his/her candidature will be cancelled forthwith irrespective of merit position in the CBT. The concerned candidate shall be solely responsible for this (i.e. his/her disqualification).

10. All the certificates which are provided by the candidate may be sent for the police verification and if the same is found fake/tempered/false, candidature of the candidate will be cancelled and necessary legal action may be initiated against such candidate.
11. No TA/DA will be paid for appearing in the Document Verification.
